The International Iranian Economic Association (IIEA) is pleased to announce its seventh international conference on Iran's Economy to be held at the College of Humanities and Social Sciences (CHSS), Hamad Bin Khalifa University (HBKU) in Doha, Qatar on **November 27-28, 2024**.

The event follows a series of successful international conferences organised by IIEA since its inception: SOAS (its inaugural conference, 2011), Bilgi University (2013), Boston College (2014), Philipps-University of Marburg (2016), the International Institute of Social History (2018), and University of Naples 'L'Orientale' (2019). As on previous occasions, the purpose of this conference is to showcase the best current research on Iran's economy and to generate information and encouragement for future high-quality research in this area.

**The criteria for the selection of papers are:** (i) relevance to Iran's economy; and (ii) quality of work and rigour of analysis. The scientific committee invites the submission of completed papers from all fields of economics; both theoretical and empirical studies are welcome.
